





WELCOME ADDRESS
J. Michael Houston
Mayor of Springfield

Michael Houston became the 23rd Mayor of the City of Springfield on April 29, 2011. He has previously held the positions of Chairman, President, and C.E.O. of the Town & Country Bank of Springfield. In February 2009 he retired from the bank and was named Chairman Emeritus.

Prior to that Mr. Houston served for 16 years at Bank One, Illinois NA as a Senior Vice-President and was responsible for the Investment Management Group in central Illinois. He served as the Mayor of Springfield from 1979 to 1987.

Mr. Houston is presently the chairman of the Western Illinois University Board of Trustees, having been appointed to the board in May 1997.

A Springfield native, Mayor
Houston is the Chairman of the
Board of St. John's Hospital and a
former Chairman of the Board of
the Greater Springfield Chamber of
Commerce. He serves on the Board
of Directors of Downtown
Springfield, Inc., the Quantum
Growth Partnership, the Heritage
Foundation, and the Abraham
Lincoln Council of the Boy Scouts
of America.

Mr. Houston received his bachelor's degree from Illinois State University and his MBA from the University of Illinois at Urbana.
